Title Compliance and Real Estate Reports:

Real Estate Report as of 7/11/2023

There are no homes in Lake Arbor that are currently active on the market.

There are four homes under contract and pending a closing. List prices range from \$549k to \$725k.

Since the beginning of the year, 19 homes have sold and closed with a range of \$430k to \$750k and average sold price of \$623k.

During the same time period of 2022, 28 homes sold and closed with a range of \$415k to \$828k and average sold price of \$614k.

Year over year, the number of homes that have sold in Lake Arbor decreased 32%. Fewer homes went on the market this year compared to last year.

Average closed price of sold homes increased 1.5% from the previous year.
